USE OF THIS BULLETIN: Proposals presented in this bulletin are subject to University-wide review. I. NOTICE (for approval)

Media Arts (MA): The Department of Media Arts, with the approval of the Faculty of Fine Arts, proposes to establish a major in media arts for the Master of Arts degree. The proposed major will fill a substantive need in the discipline by integrating theory, criticism, and history in film, television, and video studies on the master's degree level. A minimum of 31 units and a master's report to be presented at departmental colloquia will be required. Eleven new permanent courses will be established. Need for the program is demonstrated by the steady growth of enrollment in the cinema emphasis within the drama major for the M.A. degree, the precursor of the proposed program. During the next five years, it is anticipated that approximately 120 students will enroll in the proposed program. Ten faculty currently support the program; two new faculty positions will be required during the first five years. The proposed program is not presently offered at any institution in the state; related programs in journalism and communication stress print media and social effects rather than critical and historical media studies. Graduates of the proposed program will be prepared for a doctoral program or a career in media arts at art museums, media arts centers, community colleges, university presses and journals, and in private industry. The proposal was approved by the Graduate Council on April 20, 1990.
