The Society for Range Management, founded in 1948 as the American Society of Range Management, is a nonprofit association incorporated under the laws of the State of Wyoming. It is recognized exempt from Federal income tax, as a scientific and educational organization under the provisions of Section 501(c)(3) of the Internal Revenue Code, and also is classed as a public foundation as described in Section 509(a)(2) of the Code. The name of the Society was changed in 1971 by amendment of the Articles of Incorporation. The objectives for which the corporation is established are:

- to promote wise stewardship of global rangeland resources;
- to develop an understanding of rangeland ecosystems and management principles necessary to support them;
- to disseminate contemporary knowledge and techniques to individuals and organizations interested in the science and art of rangeland stewardship;
- to sustainably provision ecosystem services from rangelands to benefit human societies;
- to create a public appreciation of the economic and social benefits obtained from rangeland ecosystems;
- to support professional development of its membership.
